

**Minutes MGDPOA Meeting, November 10, 2016**

**Minutes:**

- Minutes of the September 12, 2016 meeting were distributed and reviewed. Cathy G noted that it was actually Ros, not her who bought the chips for the last BBQ. Bev moved that the minutes be accepted and this was seconded by Cathy G. Carried

**Business Arising from Minutes:** None

**Fall BBQ Review:**

- Members felt that the BBQ had gone well despite the less than perfect weather.
- Cathy G reported that the Rainbow auction brought in \$230, Food sales were \$319, memberships and donations brought in \$590.05 and \$38.94 from the square.
- Note Heather reports there were 70 tickets handed in for hot dogs
- We received excellent support from our vendors including Global Pet Foods, Aardvark Pets, Pet Valu and Safeway who supplied prizes and food. Bev has thanked them on the Facebook page.
- Heather suggested that as we are not actually trying to make money at this event, we consider going back to giving away hot dog, chips and a drink for each membership purchased. Additional food could then be purchased for other family members.

**Dog Park Cleanliness and Safety Issues:**

- New wood chips have been delivered by both the City and Parkland Tree Service. The City will spread these in the near future at the front area and along the road where ruts have developed. More will be required due the large amount of rain we had this fall.
- The City also put up new signs pointing out where the "Off Leash area" actually is but we still feel a few more would be helpful to get people to the actual park area.
- Ros reported that she walked around with Jessica from the City when she ran in to her at the park and discussed some of the things that needed doing.
- Ros pointed out that work is again needed on the ditch at the front as gravel is washing away and the culvert needs cleaning out. They may put some boulders at the East end of the culvert.

**AGM Planning:**

- Meeting is scheduled for December 1, 2016 at the Louis Riel Library. Notices have been put up around the park and on line.
- As we really want to encourage a good turnout it was decided to purchase gift certificates from those sponsors that have helped us out in the past. Cathy Kelly volunteered to purchase \$100 gift certificates from Global Pets, Pet Valu and Aardvark Pets.
- The agenda for the AGM was planned including election of new officers.
- To ensure those voting are members in good standing coloured markers will be handed out to them as they enter the meeting.
- Bylaw changes will be posted on line and at the park and have been sent out by Don Lowrie by mail chimp so that they can be voted on at the AGM. (see attached proposed bylaw changes). Bev will discuss these at the AGM. They will also be handed out and read at the meeting.
- May want to have an idea list available so that as people enter they can write down suggestions.

**Discussion of members in good standing:**

- There was discussion of this item but no vote was taken as it was decided that for the next AGM we would continue to recognize anyone who has paid their membership up to and including December 1, 2016.
